We are Octagon Professionals International B.V. We are committed and see it as our responsibility to protect your privacy. We collect and process your personal data in accordance with the General Data Protection Regulation (GDPR). We only process your personal data for the purposes set below. In this privacy policy, we would like to inform you about the personal data we collect, how we collect this data, why and when we collect this data, and how we protect this data.

Why do we collect your personal data?

We collect and process your personal data for the execution of our services, including recruitment & selection, personnel management, administration, employment and, payroll. Collecting and processing your personal data enables us to carry out these services for you.

When do we collect your personal data?

We collect your personal data when:

- you visit our website.
- you fill in your personal data on our website.
- you submit your cv or personal data via email or other communication channels.
- a reference contact that you specified gives us your personal data.
- it is publicly available on social media platforms. We use this data to evaluate if you'd be interested in a job or suitable for a position we have.

Legal basis

We only process your personal data where:

- you have given us consent to do so for a specific purpose. Your consent can be withdrawn at any time.
- you reached out to us with the purpose of concluding a contract with us.
- we need it to comply with a legal obligation.
- it satisfies a legitimate interest, including offering the most suitable candidate for the respective position and offering the best possible position to the candidate.

Personal data we collect

Personal data we collect from candidates & applicants



When you register with us or apply for a vacancy, we collect the following personal data:

- First and last name
- Address
- Date of birth
- Contact information (Email address and telephone number)
- information in your CV
- Job preferences

When we search for candidates through websites such as LinkedIn, we gather the following personal data:

- First and last name
- Email address
- Phone number
- Employment history
- Education history

Personal data we collect from companies and company contacts

When you schedule a consultation on our website or contact us, we collect the following personal data:

- Name
- Contact information (email address and telephone number)
- Job title

You may choose not to provide us with certain personal data; in that case, you may not be able to take full advantage of our services.

How long do we keep your data?

We will keep your personal data for a maximum period of 2 years after the application process has ended. After 2 years, your personal data will either be anonymized or deleted from our database.

For sourced candidates, if you have given us consent to store your data in our database, we will keep your personal data for a maximum period of 2 years after the application process has ended. If you didn't give us consent, we would keep your personal data for a maximum period of 1 month after the application process has ended.



Cookies

If you visit our website, we may track the visits using cookies. Cookies are packages of data that are sent to your computer from a web server. Our website uses cookies to distinguish you from other users on our website. It helps us to record user-specific data such as page visits, time on page, and pages viewed. Using cookies helps us to provide better service to our visitors and gives data that is used to manage our website. Read more about cookies in our cookie statement.

With whom do we share your personal data with

We only share your personal data with the employers and our data processors for the purposes that are described in this privacy policy. We will not share, sell or otherwise distribute your data to other third parties.

All Octagon employees are bound by our internal privacy policy to work in compliance with the applicable data protection law. Only employees who need data to perform a specific job are granted access to personal data. All Octagon employees who have
